With reference to the subject and letter cited above, I am directed to inform that the information furnished by the State Govt letter under reference above has been examined in Regional Office, Shillong and found incomplete. State Govt is requested to furnish the following information:-

- The submitted enumeration list of number of tree to be affected by this proposal has not been duly authenticated by the concerned Divisional Forest Officer.
- The original or colour scanned Sol toposheet map indicating the proposed CA area i.e 6.76 ha.
- State Govt to clarify the current status of land of the broken area i.e. 0.78 ha as observed in Google earth adjacent to the proposed area as the same has not been included in this instant proposed area.
- To propose alternate CA site as about 87 % of the proposed CA site falls under moderately Dense Forest, as observed in the DSS software.

State Govt is requested to kindly furnish the above information for further processing of this proposal.
