With reference to the subject and letter cited above, I am directed to inform that the information furnished by State Govt letter under reference(i) above has been examined in this office and found incomplete. State Govt is therefore requested to submit the following information to this office for further processing of this instant proposal. :-

1. The corrected kml/shape file of the identified 18.4 ha CA area patch in Lumding Reserved Forest in Nagaon district as the area of the submitted kml file is incorrect i.e 12.99 ha.
2. The site inspection report submitted does not mention the density of canopy though in the submitted photographs, the tree species and bamboo are seen. State Govt may mention the density of forest cover.
