HELD ON 24th June, 2025**

वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 तथा वन (संरक्षण एवं संवर्धन) नियम, 2023 के तहत वन भूमि प्रत्यावर्तन से संबंधित लंबित प्रस्तावों पर चर्चा करने हेतु पाक्षिक क्षेत्रीय समन्वय बैठक (FRCM) दिनांक 24 June, 2025 को अपराह्न 3:00 बजे श्रीमति नीलिमा शाह (भा०व०से०), सहायक महानिरीक्षक वन (केन्द्रीय) की अध्यक्षता में क्षेत्रीय कार्यालय, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, देहरादून में बैठक आयोजित की गई।

At the outset, Mrs. Neelima Shah, AIGF, welcomed all participants in the meeting and further forest diversion related matters/ proposals as desired/ proposed by the State Government/ Project Proponents/ User Agencies were discussed in the meeting:

Agenda Item No. 01

Proposal for renewal of lease of 2.41 ha forest land for Kendriya Vidhyalaya School (KVS), Rishikesh in favour of Kendriya Vidyalaya Rishikesh, IDPL, Virbhadra, Rishikesh, Uttarakhand within the jurisdiction of Dehradun Forest Division, in Dehradun District of Uttarakhand (File no. FP/UK/SCH/ 40755/2019).

The proposal was discussed with the User Agency and the DFO, Dehradun Forest Division. The user agency gave the following information on KVS, Rishikesh, IDPL:

1. The DFO, Dehradun submitted that total 799 ha of forest land was granted to IDPL on lease before 1980.
2. The school was established in year 1978 (as per the submitted school register) as a project school to facilitate the educational needs of wards of IDPL employees in the campus of IDPL.
3. At that time maintenance and financial responsibilities were initially managed by IDPL.
4. In the year 2000, due to financial issue, the IDPL was unable to provide maintenance and financial responsibilities due to which school was closed down.

5. Again, on a lot of public and local administration demand, the school was reopened in the year 2003.
6. The Principal (KVS) submitted the original admission register from 1978 as proof of historical presence, but no lease deed/certificate or land transfer documents or any kind of request letter for opening of KVS from IDPL were available with the user agency.
7. The DFO Dehradun clarified that the original lease was granted to IDPL for 50 years of 799 ha forest area. After expiry of lease given to IDPL, about 500 ha area has been received by Forest Department. Remaining area has been encroached by employees/villagers and the said area is under sub-judice.
8. The KVS and other institutions (such as the Income Tax office and an Inter College etc) are also falls in the said encroached area.
9. The Principal (KVS) submitted that after several meetings with forest officials (CF, DFO and RFO), no supporting documents have been found due to their unavailability.
10. The Principal (KVS) also mentioned that school maintenance is currently overseen by the SDM (Sadar).
11. Currently, the IDPL lease has been expired in year 2021 and the KVS, Rishikesh submitted a renewal of lease proposal in 2019 before expiry of the IDPL lease.

After detailed discussion, it was found that the User agency has no any previous lease documents nor any kind of request letter from IDPL for opening of KVS but it is observed that the school is running since 1978. The user agency is instructed to change the proposal title from "Renewal" to "Post-facto-approval for diversion" in all relevant documents and Parivesh portal. The User Agency shall also submit a brief note outlining the chronological background history. A fresh proposal must be submitted as per current Rules and Regulations.

Agenda Item No. 02

Diversion of 4.879 ha of Forest Land for Construction of road from Village

Margaon-Jaspur-Chamiyari to Ulan motor road in distt Uttarkashi block Chinyalisaur in favour of PWD within the jurisdiction of Uttarkashi Forest Division, Dehradun District of Uttarakhand. (File no. FP/UK/ROAD/20224/2016).

The proposal was discussed with the concerned user agency, who were present in person. The user agency informed that they have submitted the revised amount of Net Present Value (NPV); however, they have not yet received Stage-II clearance.

*After detailed discussion, it was observed that the User Agency has deposited additional/revised amount of NPV in CAMPA fund but the same reflects as **UNPAID** on Parivesh portal. Therefore, the User Agency shall deposit the additional/revised amount of NPV in CAMPA fund and ensure that the same reflects as **PAID** on Parivesh portal.*

Agenda Item No. 03

Diversion of 17.72 ha of Forest Land for construction of Tarai and Chakpheri feeder canals under Jamrani Dam Multipurpose Project in favour of Irrigation Department within the jurisdiction of Haldwani Forest Division, in Nainital District of Uttarakhand. (File no. FP/UK/Canal/ 498497/2024).

The proposal was discussed with the concerned user agency, who joined the meeting via video conference (VC). The user agency informed that the Haripura canal was constructed prior 1980. Further, the user agency and the DFO concerned gave the following details regarding the project:

1. The Jamrani Dam is a Multipurpose Project and proposed on the Gola River in Nainital district. The Jamrani Dam was constructed prior to 1980 alongwith Haripura canal. The said land has been transferred to Irrigation Department prior to 1980.
2. Due to some reasons, the water supply was not carried out in Haripura canal till.
3. In between the period, there is many of natural trees grown in the canal area and this time total number of trees are 3881. Out of this, the Irrigation Department seeking approval for felling of 2567 numbers of trees from State Forest Department.

4. The User Agency also submitted that the 351.55 ha of forest land is already diverted to User Agency on 16.01.2023 by MoEF&CC, New Delhi.

The User Agency requested that the tree felling in the canal area is necessary to start water flow in canal.

After detailed discussion, the Regional Office, MoEF&CC observed that the proposal does not involve any kind of diversion of forest land and involves only felling of trees. Thereafter, the user agency was advised to submit the proposal to State Forest Department, for further consideration and necessary approval.

The meeting ended with a vote of thanks.
