In your Memo under reference you have submitted the above
diversion proposal which is found to be processed very haphazardly and casually
at your level due to the following discrepancies:

1. Instead of submitting five copies of the above diversion proposal, you have
submitted only one copy of the same.
2. The hard copy of the diversion proposal has not been paginated.
3. The check lists have not been signed by you.
4. The land schedule of the forest land proposed diversion has not been
enclosed in the diversion proposal. It should be furnished with the status of
the same as on 25.10.1980 duly certified by the Tahasildar concerned.
5. The Part-II of the proposal has been left blank.
6. The Site Inspection Report of the Dy.CF has also not been enclosed.
7. The Compensatory Afforestation Scheme is not as per the current wage rate
of Rs.286.30 per man day.

Therefore, the above diversion proposal is returned herewith for
re-submission which should be resubmitted after proper scrutiny at your level.
You should avoid uploading such incomplete proposal in the MoEF Portal in
future.
