Sub: Diversion of 2.9696 ha of forest land in favour of Municipal Corporation Dharamshala for the construction of Solid Waste Management Plant in Up Mohal Dharamshala within the jurisdiction of Dharamshala forest Division in Distt. Kangra, Himachal Pradesh. - FP/HP/Others/48483/2020

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में निम्नलिखित कमियां पाई गई हैं:-

1. Regarding point no 6 of EDS raised by IRO Shimla vide letter dated 27-08-2022 it has been submitted by the State Govt. that an attested copy of certificate regarding the possession of 1.5717 ha of forest land by user agency prior to 1980 has been enclosed. However, no such document has been provided with the letter. Therefore, necessary document mentioning the use of forest land by the user agency prior to 1980 may be provided.
2. In case of non-submission of documentary proof as mentioned above, it will be presumed that the area of 1.5717 ha of forest out of 2.9696 ha proposed in the extant proposal has been used by the user agency violating the norms of FCA, 1980. Further, following documents may be provided:
 - i. The Action Taken Report against the violators as per Para 1.21 (i) and/ or (ii) of FCA Guidelines may submitted/ uploaded in the portal.
 - ii. Action taken by the State Government against the officials concerned for not being able to prevent the use of forest land for non-forestry purpose without prior approval of Govt. of India.
 - iii. Calculation sheet of Penal NPV for 1.5717 ha of forest land being used without prior approval of Central Govt. under FCA, 1980, as per para 1.21 of FCA guidelines may be provided.
3. Consent to Establish for construction of Solid Waste Management Plant may be provided from HPSPCB.
