Sir,

Please refer to the Government of Manipur letter No. 20/52/2022-For&Envt dated 08.06.2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case:

- 1) The Conservator of Forests, Central Circle has recommended 2 Biodiversity parks with the Concept Paper submitted being only for Development of one Biodiversity Park at Lamprai Chingjin, Khongampat Awang Leikai at an area of about 1 Ha with an estimated cost of Rs. 88.50 lakhs. No comments / recommendations of Nodal Officer, PCCF & HoFF and the State Govt have been received. Hence, the same may be clarified by the State Forest Department
- GPS Coordinates of the proposed forest land for diversion along with GPS Coordinates of Starting and End points to be depicted on map.
- 3) The current status of the land proposed for diversion seems undetermined & matter is still pending in Hon'ble High Court of Manipur. The State Govt may furnish justification.
- 4) FRA certificate for 8.0102 ha in Imphal West Distt. may be furnished

The above additional information may be furnished at the earliest so as to enable this office taking further necessary action.
