Sub.: Objections regarding FCA Cases

It is to inform you that the following objections have been raised by IRO office Chandigarh, in various diversion cases. You are requested to pay attention on following issues while submitting all diversion cases to Nodal office in future so that the cases may be approved without any delay and unnecessary correspondence may be avoided.


1. In online part II, all Species details with their Scientific name, Local name to be uploaded .
2. Undertaking for " No other retail outlet with 300 m and no toll plaza within 1000 m on both sides of the proposed site " to be submitted.
3. In online part II, under column 4(i) vegetation density and Eco class to be correctly uploaded . Accordingly NPV for open/ dense forest to be calculated .
4. Separate NPV calculation sheet needs to be submitted for corresponding vegetation density and Eco Class . It should never be mixed with the CA scheme proforma.
5. Land Suitability certificate needs to be revised indicating range, Compartment, and details of Road (From _____ to _____)etc.
6. Temporary /Permanent employment generated in person days to be uploaded correctly in respective part .
7. Validity of various NOC's , Genuineness ,LOI to be checked before submission .

8. In online Part I , check whether Authority letter is uploaded for same person who is making application for forest clearance.
9. SOI toposheet should have Toposheet No and indicate project site on it before uploading .
10. Layout plan should be approved from competent authority ie. PWD, NHAI. etc.
11. DFO is required to countersign all undertakings provided by the User Agency before uploading.
12. Justification for providing more area of KML file of CA for just 100 plants in view of monitoring and protection point of view and how the provision of barbed wire fencing be utilized for protecting the proposed CA area. It should be checked for each site before preparing CA scheme .

Above points should be included in checklist already sent by this office and should be conveyed to frontline staff at your level so that they will be aware about these instructions during field visit/Inspection of sites.
