- There have directed to inform you that in the proposal it has been observed that:
1. Land suitability certificate and digital map in stipulated file of proposed C.S. are has not been provided.
 2. CA scheme file is neither available online.
 3. Details of amount of NCV to be deposited have not been provided.
 4. Certificate submitted under Forest Rights Act 2006, in file 13/7/15/5/0079/2014 and 7. Ind. Div. relate the proposal has been obtained for 13.58 Ha. This discrepancy in data should be rectified.
 5. In Division file latitude and longitude of different points are given but it serves no purpose because it can not be made out in which points these references relate to. Proper digital map in stipulated file mentioning latitude and longitude may be submitted.
 6. In Part-B of the proposal it has been clearly specified that the user agency has obtained the 'Act and FDR' has been registered against the A/N/SH/Baran road/Mineral A/N/SH/Div. Chhatrapati Bhawan area and the Contractor Sh. Rajender Kumar and Sh. Jyoti Kumar. A copy of EIR - Strategy Report should be provided to this office along with the present status of FDR. The present case should be dealt according to the FCA guidelines 2014 item 7.4.
 7. In part-B also, the FCT Baran has uploaded paper related to the proposal RE/Bar/06/07/14-2013 which is not relevant and hence should be removed from the proposal.

You are therefore requested to upload the above mentioned information, documents and also send the hard copy of the proposal. On receipt of hard copy, if any further information is required, it will be informed in the due course of time.
