S.N	Additional Information required	Action to be taken
1	The compensatory afforestation scheme submitted at the cost of Rs. 11,02,100 is for maintenance of period of 8 years, whereas as per guidelines maintenance period is for 10 years. The same may be re-submitted after revision for 10 years maintenance	DFO to prepare scheme for CA with maintenance upto 10 years.
2	As per letter dated 08.06.2022 of DCF (FC), Mizoram it has been mentioned that there is violation of FC Act in this proposal. The State Govt. may assess the extent of violation and calculate the penalty as per Forest Conservation Act, 1980 Guidelines Para 1.21 (ii), if any of the FC Act along with full details of violation.	Necessary action to be taken by DFO, Thenzawl as per Ministry letter F. No. 11-42/2017-FC Dt. 29.01.2018
3	The calculation of Net present value is @ 7.30/ha. Hence NPV may be calculated as per Ministry's latest guidelines dated 06.01.2022	DFO to prepare scheme as per Ministry guidelines dt. 06.01.2022 .
