With reference to the subject cited above, I am directed to inform that this instant proposal for diversion of 5.5 ha of forest land for quarrying of stone/road metal at Longa Koireng, Kangpokpi District, Manipur in favour of The M/S Shyam Chand & Sons is received back in IRO from Ministry, New Delhi. However, Ministry has observed the following lacking information which needs to be submitted by the State Government. The observations of the Ministry is as follow:

> "Existing land use pattern, indicated as degraded forest land in the Mining Plan. The Landuse detail have proposed during the plan period of 5 years or at the end of mining have not been indicated neither in the proposal. Though the Mining Plan mention that haul roads, OB dump area with benching will be developed, however, detail of land use breakup to be used in these component envisaged in the Mining Plan has not been indicated. Only land use indicated on the cover page of Mining Plan is 5.5 ha for mining, including 0.73 ha of safety zone".

In view of the above, the desired information may be submitted at the earliest so as to unable this office for taking further necessary action.
