महोदय,

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- The proposal involves felling of 61 trees in the proposed 9 m road width. The aim of the proposed road is to provide connectivity to one village having a population of 240, which can be done even after reducing the road width up to 5 or 6m. The State Govt is requested to review the same and minimize the number of trees proposed to be felled.
- 2- The locations of the villages to be benefited by the proposed road are not marked on the KML file. Accordingly, the State Govt. is requested to mark the locations of concern villages in the KML file uploaded in the online portal.
- 3- The village is located within 500 m from the existing road. Therefore, the State Govt. is requested to clarify the need of the proposed road in view of existing norms mentioned in the IRC for hill roads.
- 4- NPV is calculated at older rates. State Govt. is requested to submit/ upload NPV calculation sheet as per the new rates.
- 5- A road already exists on the downward side of the village. Hence, the State Govt. is requested to submit the comments of User Agency on the feasibility of connecting the existing road from the most appropriate point on the existing road, thus, reducing the number of trees affected and the requirement of forest area.
- 6- The proposed alignment and the alternate alignment end at different points. It is requested to the State Govt. to do the necessary correction in the alternate alignment.
