I am directed to invite a reference to your letter No.10080 dtd.21.05.2020 on the subject cited above and to say that the proposal for diversion of 0.91ha forest land for setting up Pollution Control Tank by M/s Mahakali Ispat (P) Ltd has been examined at Govt. level and the following may be clarified.

'The piece of land is situated near by the premises of the Mahakali Ispat (P) Ltd. This by itself is not a sufficient justification for the project to be considered as "Site Specific." There may be other non-forest patches, adjoining to the premises of the User Agency. Therefore sufficient reasons may be given to justify the inescapability of the site to treat it as a 'Site Specific' project.

It is therefore requested to furnish a clarification on the matter to this Department early for taking further needful action at this end.
