Sir,

During scrutiny of your above diversion proposal vis-à-vis documents, the following discrepancies have been noticed which need to be rectified and resubmitted for processing of the diversion proposal.

Undertakings/ Certificates to be furnished

- Part-I of Form A in the prescribed format is wanting.
- 2. Only pipe line route of the project has been marked in the Topo sheet, but the forest area where the pipe line to be passes not marked in the Topo sheet. Hence the portion of the slurry pipe line which is coming in Deogarh Forest Division should be shown in the Topo sheet in different ink for non forest land and forest land, and the colour should be indicated in the Index to be mentioned in the Topo sheet.
- 3. Portion of total area of the present Project which has been applied for Diversion in this Division should be shown in Revenue Map. The forest area and non-forest area should be shown in different colour, and they should be reflected in the Index in each map.
- 4. 1.337 ha. of forest land proposed to be diverted for this project. But authenticated statement showing the details of forest area involved in the project is wanting. Hence the land schedule of the forest area of 1.337 ha should be submitted as per the following format duly authenticated by the concerned Range Officer of Pallahara & Khamar Range and Tahasildar Pallahara.

- 18. Patch wise DGPS coordinates of the proposed forest land under different category involved in the project.
- 19. Check list in the prescribed format along with specific information as desired in the check list w.r.t linear project i.e. 28(a).
