Sub: Proposal for diversion of 5.40 ha of forest land for operation of Gopeswar Stone Quarry & Mining Zone Area under North Kamrup Division in favour of Sri Fatik Das, Guwahati.

Sir,

With reference to the subject and as per the site inspection conducted by this office on 03.05.2024, I am directed to inform that part of the proposed area has found to be broken and the same could also be verified from the time series data of Google Earth. State Govt is requested to provide the following information as decided in the meeting of Advisory Committee in the similar mining cases for further processing of this proposal:-

1. The copies of the forest clearance approvals earlier granted of this proposed area with compliance report, if forest clearance not obtained the action taken/reason thereof.
2. The State Govt shall carry out a holistic study of the project along with other proposed diversion within 1 Km of the extant project. The report shall examine the ecological impact of proposed quarries being in close proximity and submit a report.
3. The infrastructure/development projects for which the excavated materials are proposed to be utilized.
