

Sir,
With reference to the subject, I am directed to refer to the State Government's letter no. 5280413/FR.10/2023-4 dated 11/6/2024 on the above subject. In this regard, it is informed that while doing the exercise of reconciliation of CA areas in the Chengalpattu District, it is noted that there are 5 different Compensatory Afforestation areas of non-forest lands of about 69.705 ha for previously approved projects of Chengalpattu District are yet to be notified as RF/RL even after a lapse of 20 or 30 years and no effort was made by the State Government to notify the same. The details of the same is attached herewith. It is also informed that these areas were monitored by this office earlier and noticed some encroachment in these non-forest lands. Despite regular requests and monitoring reports, the progress in this regard is not satisfactory.

In view of the above, State Government is requested to provide a copy of the notification of non-forest land as PF/RF at the earliest to this office for further consideration of the proposal.
