Diversion of 8.0678 ha of forest land in favour of M/S FRIENDS HIM ENERGIES, C/O Near Happy Sr. Sec.School, Jail Road, Gurdaspur-143521 for the construction of Siul-iv- SHEP within the jurisdiction of Churah Forest Division distt Chamba, HP.

1. There is slight difference in the total of component-wise breakup mentioned against column No.B-2.4. The diversion has been asked for 8.0678ha whereas the total of the component-wise break is coming 8.06773ha.
2. The map of alternate alignments uploaded against column No.D(ii)a, has not even signed by the user agency. This map duly signed by the user agency and countersigned by DFO concerned is required to be uploaded against this column.
3. There is difference in the employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I. In online part-I, against column No.E(ii), '24' and against column No. E(iii), '54750', has been mentioned whereas in hard copy of part-I against column No.I(vi), 25 +50 and '54750 mandays will be generated', has been mentioned. The employment likely to be generated mentioned in online part-I and mentioned in hard copy of part-I, should tally. Necessary corrections are required to be made in online part-I.
4. As per enumeration lists of the trees, placed at P.Nos.45-46/K, 118 trees are standing over the forest land proposed for diversion but in online part-II, against column No.4(ii), 122 trees have been mentioned. The actual number of trees involved in the proposal is required to be mentioned on the portal.
5. Against column No.13(iii), although the digital map of CA site has been uploaded but has not been signed by the DFO concerned. Digital map of CA site duly signed by the DFO concerned is required to be uploaded.
6. Against column No.13(iv), although the digital map of CA site has been uploaded but has not been signed by the DFO concerned. Map of CA site duly signed by the DFO concerned is required to be uploaded.
7. As per online part-I, dumping has been proposed over 0.1967 ha of forest land in five dumping sites and detail of these dumping sites have been placed at P.No.83-84 of the proposal folder. But the detail of these dumping sites are not matching with the detail of dumping sites placed at P.Nos.61 & 62, the total of these dumping sites is coming 0.2082ha whereas as per detail of duping sites mentioned in online part-I is 0.1967ha. Further the reclamation plan of dumping sites placed at P.No.59 of the proposal folder, 0.5612 ha of forest land has been proposed to be reclaimed. When dumping has been proposed over 0.1967 ha of forest land, the plantation part of reclamation plan should be over 0.1967ha.The detail placed at P.No.61-62 is also required to be corrected as per forest area proposed for dumping sites in online part-I.
8. TEC and IA have still not been submitted with the hard copy of the proposal. If not obtained, the latest status of both the documents is required to be intimated.
