Subject: Diversion of 4.2502 ha of forest land in favour of M/S HIMPRABHA Power Private Limited Village Karnguhi, PO Panthera, Tehsil Ghumarwin Distt Bilaspur, HP, for the construction of 4.8 MW Kurpan-II Small HEP in Distt.kullu/Shimla, within the jurisdiction of Ani & Rampur Forest Divisions distt Kullu and Shimla, HP.

Kindly refer to your office letter No.1840 dated 15.6.2016 on the subject cited above.

2. The following shortcomings have been noticed in the proposal, which may be completed.

1. Approximate distance of the proposed site for diversion from boundary of forest (in km) has not been mentioned.
2. In online part-II, against additional information detail, 11 documents have been uploaded but nothing has been mentioned about the detail of these uploaded documents. The detail of each document is required to be mentioned against remarks column.
3. In the hard copy of the proposal (P.No. 25 & 63) pertaining to Ani forest division, the Row of Tr. Line 4.26 Mtrs has been proposed for laying of 22 KV Tr. Line and in the part of the proposal(P.No.22 & 61), pertaining to Rampur Forest Division, 4 Mtrs ROW has been proposed for laying of 22 KV Tr. Line. In this regard it is submitted that as GoI guidelines, 15 Mtrs of ROW is required for 22 & 33 KV transmission line. The proposal is required to be modified as per GoI guidelines.
