Please refer to the State Government's letter No.1768/FCA/FEWMD/275 dt. 11.06.2018 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. On careful examination of the proposal, it is observed that the State Govt has submitted this proposal for setting up of Private University in Sikkim involving 4.5 ha forest land, which is non-site specific project. The State is requested to refer to guideline 2.1 (vii) para 3 of FC Act and provide complete justification for establishing and its in-escapability for location the project in forest land. Also whether alternative sites have been explored for setting up of private university, if so the reasons for their rejection in detail.
