Sir,

During scrutiny of your above diversion proposal vis-à-vis documents, the following discrepancies have been noticed which needs to be rectified and resubmitted for processing of the diversion proposal.

Undertakings/ Certificates to be furnished

1. Payment towards Additional NPV, if so determined as per final decision of Hon'ble Supreme Court of India.
2. Certificate towards payment of NPV in respect of all other mines/ projects of the lessee situated in Keonjhar District and State of Odisha.
3. Certificate under FRA-2006 in respect of forest land.
4. Compliance as regards violation committed during ML, if applicable.
5. Certificate as regards Status of land (Forest and Non-forest) as on 25.10.1980.
(N.B.- The status certificate should be correct and complete in respect of all plots involved in the Mining Lease).
6. Pending Court Matters, if any.

1. SOI Topo Sheet (1:50000) showing forest land required for diversion and boundary of adjoining forest land.
2. Original lease plan.
3. Lease plan as per RML application.
4. Approved land use plan under FC Act, 1980.
5. Present land use plan.
6. Proposed land use plan in respect of applied forest land.
7. DGPS map showing Patch wise DGPS coordinates of the forest land under different category involved in the mining lease proposed for diversion and DGPS coordinates of all patches of forest land involved in the ML.
8. Cost benefit analysis of the project.
9. Village wise break up of forest land proposed for diversion.
10. Details of approvals obtained/ sought for under the Act in respect of the project.

11. Correct status report as regards area of non-forest land as on 25.10.1980 involved in the instant proposal.
12. Separate land schedule of forest land applied for diversion in the instant proposal.
13. Details of land identified for CA with GPS coordinates of the identified site.
14. Check list in the prescribed format along with specific information.
15. Revised proposed forest land use plan in compliance with para- 4.5 of FC Act Guideline.


