I am directed to refer to the State Government's letter No. FEE 237 FLL 2024 (e) dated 01.03.2025 seeking approval of the Central Government in accordance with Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adihiniyam 1980 . The following clarifications are requested for further processing of the proposal:

- The State Govt. is requested to clarify whether the proposed OFCs is being laid in the existing RoW of the diverted road or otherwise. If it is being laid along the existing RoW of the road which has already been allowed for non forestry use, then proposal can be processed as per as per para 4.2 of comprehensive guidelines issued under VSESA 1980.
- Location of tower where the proposed OFC is being connected is within the forest area or otherwise. If the tower is within the forest area, then whether approval under VSESA 1980 has been obtained or otherwise.
- In point no. 8 (ii) of Form A part-II, the DCF has mentioned that the area proposed for diversion is part of the Protected Area, while the nodal officer vide letter dt 12.08.2024 has informed that the area proposed for diversion is located within ESZ of Kudremukh National Park. In this regard State Government may be requested to offer its comments.
- If the OFC is being laid through the RoW of the road which has already been

allowed for non-forestry use to another department, then the NoC from the concerned department is also required.

Further, it is to inform that if the OFC is being laid along the existing RoW of the road which has already been allowed for non forestry use, then proposal need to processed as per as per para 4.2 of comprehensive guidelines issued under VSESA 1980.
