- vi. The User Agency shall furnish an undertaking to pay the additional amount of the Net Present Value (NPV) of the proposed diversion of forest land, if any, becoming due after finalization/ revision of the same by the Hon'ble Supreme Court of India.
- vii. The GPS coordinates of the proposed area in Degree Minutes, Second format.
- viii. The cost benefit analysis of the project, if the proposal is for exploitation/ extraction/ harvesting of hydrocarbon/ natural gas as per the new format.
- ix. The corrected shape/.kml file of the proposed area as the submitted shape file is having 1.30 ha which is different from the proposed area.
