- ix. A copy of the approved mining plan dated 04.02.2009 as mentioned in the submitted form Form-A, Part-I
- x. The cost benefit analysis of the project, if the proposal is for exploitation/ extraction/ harvesting of hydrocarbon/ natural gas as per the new format
- xi. The corrected shape/.kml file of the proposed area as the submitted shape file of the proposed is incorrect i.e 1.63 ha instead of 1.28 ha as proposed and mentioned in the hardcopy submitted.
