In continuation of this office reference 7th cited, it is to inform that, the Forest Range Officer, Banswada through reference 6th cited has reported that, for diversion of 4.115 Ha. of forest land in Nizamabad Division for laying of pipe line and construction of structures in Segment 12/3 (Banswada) for providing safe drinking water in Nizamabad District i.e, set No.1 falls in Rampur Section of Banswada Range jurisdiction with a proposed diversion area of 1.564 Ha.

Further it is to inform that, the Forest Range Officer, Banswada has inspected the proposed area on 06.06.2016 and noticed that, the User Agency has proposed for laying of pipe line from Latitude 18.38156 Longitude 77.93615 to Latitude 18.36602 Longitude 77.97550 for a length of 4500 Meters.

As observed from the field conditions, from Latitude 18.36876 Longitude 77.96981 to Latitude 18.36602 Longitude 77.97550 for a length of 720 Meters falls in Gandhari Range of Kamareddy Division jurisdiction. But the User Agency has submitted proposals for the length of 4500 Meters in Nizamabad Division instead of 3780 Meters in Nizamabad Division and 720 Meters in Kamareddy Division. Hence the proposals may be revised.

Further it is to inform that, the area proposed by the user agency from Lat. 18.37481 Long. 77.95716 to Lat. 18.36876 Long. 77.96981 for a length of 1517 meters is falling in the middle of the new road proposed from Banswada to Uppalwai under Forest Conservation Act. The enumeration of trees for widening of road has also been completed. The proposal for diversion of 4.306 Ha. of Forest land in Banswada to Uppalwai Road of Nizamabad district have already been submitted to the Prl. Chief Conservator of Forests (HoFF) Telangana State, Hyderabad for onward transmission to the Government for taking further necessary action.

In view of the above, it is requested to revise the diversion proposals by splitting the proposals with 3780 Meters or find out an alternative and submit the same in the Office of Divisional Forest Officer, Nizamabad and submit the proposals for remaining 720 Meters in Office of Divisional Forest Officer, Kamareddy Division and also clarify whether it is possible for laying of pipe line in the middle of the road which is already proposed by the R&B Department for widening of road from Banswada to Uppalwai.
