Subject: Diversion of 0.2886 ha of forest land with felling of 22 trees (0.1144 ha protected forest in Forest Division Orai with felling of 14 trees and 0.1742 ha of protected forest in Forest Division Jhansi with felling of 08 trees) for construction of 765 kV D/C LILO Satana Gwalior transmission line by Power Grid Corporation of India Limited-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The details of area calculation uploaded as additional document in part I is not based on approved RoW for 765 kV S/C of 64 mts width. This issue need clarification and rectification.
2. Uploaded Gazette notifications of forest land have not been certified by the concerned DFO.
3. Joint inspection report of Forest Division Orai shows existence of 63 trees whereas enumeration list in part II shows 14 trees only.
4. (a) The site inspection report of DFO Orai does not clarify issues regarding violation of FCA 1980.
(b) The site inspection report of DFO Jhansi does not specify legal status of forest land proposed for diversion.
5. NOC from NHAI/SPWD (owners of the land) for proposed forest land for diversion for Forest Division, Jhansi and Orai have not been provided with the proposal.
6. The certificate regarding "Van Swaroop" forest land for Forest Division Orai has not been provided with the proposal.
7. The proposal has been submitted without submission of abstract of enumeration of trees & poles existing on forest land and abstract of enumeration of trees & poles required for felling.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
