Please refer to your office letter No. 2263 dated 30-06-2022, on the subject cited above.

2. Proposal for the Diversion of 1.9683 hac of forest land in favour of HPPWD for the construction of link road Gadasu Lauthi Punan road Road received vide letter under reference has been has been scrutinized in this office and it is observed that the same has not been prepared in a proper way and certain shortcoming/ discrepancies noticed as under :-


1. Date , place and name of signatory authority has not been mentioned in the MoEF Checklist placed in the proposal folders. The stamp of the Chief Conservator of Forest affixed on the MOEF Check List needs to be deleted.
2. In the column No.I (ii) of Part-I placed in the proposal folder page number has not been mentioned.
3. In the column No.10(i) 10 (ii), 10 (iii), 10 (v) & 11, of part-II placed in the proposal folders there is no page numbers mentioned. Please see to it.
4. Sol survey sheets, Line Map Plan and digital map of the project placed in the proposal folders should bear the name of signatory authority.
5. The check list 10 placed in the proposal is not adequate . This should be prepared by giving complete detail of area and trees involved in the alternative examined and reasons for their rejections.
6. In the check list No.11 placed in the proposal folder name of the signatory authority has not been mentioned. Please see to it.
7. Check list No.8 placed in the proposal folders has not been authenticated by the DFO. Please see to it.
8. The check list No.12,13 and page 30, placed in the proposal folders, should bear the name of signatory authority.
9. The documents/papers placed in the proposal folders, are the photocopies, which is not tenable. These should be got attested by the issuing department.
10. The abstract of the trees placed in the proposal folders at page 49, should bear the name of signatory authority.
11. In the site inspection report ,it is reported that the User Agency has violated the procedure of FCA 1980, but the detailed report of violation by DFO is not placed in the proposal folders.

12. There is violation in construction of area, as such penal CA for the two times of broken area be also prepared and placed in the proposal folders alongwith, SoI survey sheet, digital map and Land Suitability Certificate.
13. The name of signatory authority be mentioned in the SoI survey sheet and digital map of CA scheme placed in the proposal folders.
14. The Khasra number of the land identified for CA scheme needs to be mentioned.
15. The CA scheme be worked out on the current wage rates. The cost of nursery also does not seems to be included. The name of signatory authority may also be mentioned. Please see it.
16. There is no date mentioned in the check list No. 19 & 20 placed in the proposal folders.
17. There is no date and place mentioned in the documents placed at page 61.
18. There is no date and place mentioned in the certificate placed in the proposal folders at Page 77.
19. The dumping sites have been proposed over the forest land ,therefore may explore the possibility to shift the dumping site to non forest land, so that use of forest land could be minimized.
20. The certificate from the concerned DFO that no plantation work has been carried out under any scheme or programme in the proposed CA area be submitted and placed in the proposal folders.
21. It is also mentioned here that DFO has only submitted the case to this office in offline mode and the case in the online portal is still pending with him.
22. All the documents be placed in the other two folders duly attested by the competent authority.

Therefore, you are requested to attend the above observations and resubmit the case complete in all respect , so that case be further processed accordingly Please also ensure that the index and page markings in the proposal folders be done with blue pen . The proposal folders as received are returned herewith for the needful.


