Subject: Diversion of 2.27 Ha of forest land for Construction of road from Hinglot to Madnakheri in Rajasthan in Baran Forest Division.

On the above mentioned subject this office has received an online proposal for clearance under Forest (Conservation) Act-1980. The hard copy of the proposal has not been received in this office till now. The details of the proposal are as given below-

In the proposal it has been observed that-

- 1- In the site suitability certificate the DCF has found land suitable for CA but he has not submitted it online.
- 2- Digital map (in kml file) of the proposed CA Land has not been submitted.
- 3- Points given in the Google KML file are not sufficient to know the area proposed for diversion. The revised digital map (in kml file) of the forest land proposed for diversion should be submitted.
- 4- The status of Employment likely to be generated during construction of road has not been given.
- 5- In the FRA Certificate, the area of proposed forest land for diversion is shown as 3.00 Ha for areas falling in Pali Villages while project has been submitted for diversion of 2.27 Ha in three villages namely Hinglot (0.57 Ha), Bishankhera Chaina (1.03 Ha) and Madnakheri (0.67 Ha).

I have been directed to inform you to provide the above mentioned information along with the hard copy of the proposal. On receipt of hard copy, if any further information is required, it will be informed in the due course of time.
