**Sub: Diversion of 4.837 ha of Forest Land for Construction of 132/33 KV Transmission Line from Grid Sub-Station, Boudh to proposed 220/132/33 Grid Sub-Station at Kiakata of Athmallik Division**

Ref: Your Memo No.2313 dated 23.06.2023

In inviting a reference to the aforesaid office memo on the captioned subject, I am directed to inform you that during scrutiny of the diversion proposal, the following shortcomings have been noticed-

1.The Project Proponent has mentioned about the requirement of forest land of 5.475 ha in the Form-A(Part-I) uploaded in the Web Portal of the MoEF & CC (Page No.6-9/DP), out of which the requirement forest land in Athmallik Division is 5.185 ha. but in the hard copy of Form-A( Part-I) submitted by the Project Proponent (Page No.17-18/DP), Part-II and Site Inspection Report of the DFO enclosed at Page No.14-15/DP and 12-13/DP respectively, the requirement of forest land in Athmallik Division is 4.837 ha.

Further, in original application uploaded in Web Portal, there is requirement of 0.69 ha of non forest land in village Damodarapur but in the hard copy of Form-A( Part-I) submitted by the Project Proponent (Page No.17-18/DP) and land schedule furnished at Page No.33/DP, Damodarapur village has been deleted and Village Baradakata with an area of 0.292 ha has been included.

2. In the Form-A(Part-I) uploaded in the Web Portal of MoEF & CC, GoI, the Project Proponent has mentioned about the requirement of non-forest land of 46.701 ha (Boudh Division 9.06 ha and Athmallik Division 37.641 ha) furnished at Page No.8-9/DP where as in the hard copy of Form-A (Part-I) submitted by the Project Proponent (Page No.17-22/DP) and the land schedule duly authenticated by Tahasildar Athmalik Tahasil (Page-34/DP), the requirement of non-forest land is 35.368 ha.

Thus, there is requirement of change/ correction of forest and non forest area in Form-A(Part-I) uploaded in Web Portal as per land schedule authenticated by Tahasildar Athmalik. Also in village list, the village Damodarpur to be deleted and Village Baradakata to be added as per land schedule enclosed.

In view of the above, the three sets of DP along with enclosures are returned herewith for necessary correction in Form-A(Part-I) in Web Portal and re-submission to this office at the earliest for taking necessary action at this end.

**Sub: Diversion of 0.29 ha of Forest Land for Construction of 132/33 KV Transmission Line from Grid Sub-Station, Boudh to proposed 220/132/33 Grid Sub-Station at Kiakata under EHTC Division, OPCL, Angul**

Ref: (i) Your Memo No.1949 dated 03.05.2023

In inviting a reference to the aforesaid office memo on the captioned subject, I am directed to inform that during scrutiny of the diversion proposal, the following shortcomings are noticed-

1. The UA has uploaded the requirement of forest land for the project to be 5.475 ha (Boudh Division 0.290 ha + Athmallik Division 5.185 ha) in the website of the MoEF & CC (**Page No.6-11/DP**), where as in hard copy of Form-A (Part-I) submitted by the UA at **Page No.22-27/DP**, Part-II, Site Inspection Report of the DFO, Boudh Division and land schedule enclosed at **Page No.13-18, 19-20/DP and Page-29/DP** respectively, there is requirement of forest land of 0.290 ha in Boudh Division and 4.837 ha in Athmalik Division. Thus , there is requirement of change in forest area in Form-A(Part-I) of Web portal and at SI No 10(i) of Part-II as per detail land schedule authenticated by Tahasildar, Athmalik.
2. As regards requirement of non-forest land for the project uploaded in the website of MoEF & CC, the UA has mentioned 46.701 ha (Boudh Division 9.06 ha and Athmallik Division 37.641 ha) enclosed at **Page No.6-11/DP** where as in the hard copy of Form-A (Part-I) submitted by the UA at **Page No.22-27/DP** and land schedule authenticated by Tahasildar , Athmalik Tahasil, total requirement of non-forest land is of 44.428 ha (Boudh Division 9.060 ha and Athmallik Division 35.368 ha). Thus, there is requirement of change of non forest area as per land schedule of Athmalik Division in Form- A(Part-I) uploaded in the Web Portal.

3. The DFO, Boudh Division has enclosed the land schedule of forest and non-forest land of both Boudh and Athmalik Division. The land schedule of Boudh Forest Division both forest and non forest land with 25.10.1980 certificate on non forest land by Tahasildar concerned duly countersigned DFO need to be enclosed.


In view of the above, the three sets of DP along with enclosures in 3 sets are returned herewith for further compliance and re-submission at the earliest for taking necessary action at this end.
