महोदय.

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सुचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. As per DSS analysis, 2 ha area found in VDF and 4 ha in MDF. DFO may inspect the area and submit Site Inspection Report or a certificate mentioning if 1000 trees per hectare can be accommodated or not. If not, then the plantation scheme as per guidelines dt. 08.11.2017 may be submitted.
- 2. On perusal of KML file, it is noticed that the village is already connected with the road and the proposed road is ending at no habitation area. State Govt. may submit the justification and the purpose of construction of road.
- 3. It has been mentioned in the geologist report that the road starts from *Tanakpur Tawaghat* motor road and connect to *Shahid Jaman* Singh motor road at end point. State Govt. may submit the justification for the requirement of this another road.
- 4. Land schedule taken in 9 meter width. State Government may verify whether tree counting is done in 7 mtr or in 9 mtr.
- 5. Name of CA area not mentioned in the SoI Toposheet and digital map uploaded at para L in part I. State Government may upload the digital map of CA mentioning the name of the CA area.
- 6. On perusal of KML file of CA area, Agriculture field, house and road are visible in the CA area. State Government may submit the clarification.
- 7. Date of tree counting not mentioned in the tree enumeration list. State Government may submit the tree enumeration list with the date, duly countersigned by the DFO.

- 8. State Government may upload CWLW certificate submitted in hard copy.
- 9. Administrative approval uploaded online is showing error in opening the file. State Government may upload the same again.
- 10. Following observations are noticed in the muck disposal plan:-
  - (i) It is noticed that casual muck disposal plan prepared by the user agency.
  - (ii) The muck disposal is also not authenticated by DFO.
  - (iii) Balance muck to be disposed is mentioned as 9063 cum in 4.00 km length appear to be very less.
  - (iv) Eight dumping site not marked in the KML file.
  - (v) Reclamation plan also not submitted.

State Government may remove these shortcomings in muck disposal plan and submit/ upload the complete muck disposal plan including the details like quantity of muck likely to be generated including swell factor, quantity of muck likely to be utilized and the balance quantity to be disposed of at identified muck disposal sites, carrying capacity of the muck dumping sites, photographs of the muck dumping sites along with the reclamation plan duly authenticated by the DFO.
