Attention of the DFO, Anantapuramu is invited to the reference 6th cited, wherein he has submitted forest land diversion proposals for grant of mining lease for quarrying steatite and Dolomite in Sy. No. 30/1 of Julakalva village of Singanamala Mandal falling in Compt. No. 594/P of Mutchukota RF of Gooty Range in favour of M/s Rama Minerals, Anantapuramu District is verified and the following lapses are noticed are as below.

1. As verified from the proposals, there is no approval by the CCF, Anantapuramu on CA scheme.
2. The DFO has uploaded the CA scheme, without prior approval by the CCF, Anantapuramu.
3. As per the rules the approval shall be taken from the CCF, concern before uploading CA scheme in the Web portal.
4. Approved mining plan & the ROFR certificates are not uploaded in the Website. It should be rectified.

Hence, the District Forest Officer, Anantapuramu is requested to take necessary action on uploading the above lapses and obtain CA scheme approval before uploading in website and report compliance
