महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.99 हेक्टेयर वन भूमि की मांग की गई है।

2. राज्य सरकार द्वारा इस कार्यालय के पत्र दिनांक 09.02.2024 के बिंदु सं-(i) व (iii) का अनुपालन नहीं किया गया है, अतः प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे: -

- As per enumeration list, 1000 plants are proposed to be felled, the same needs to be uploaded in Part-II at column 4(ii). The State Government in its reply submitted that re-inspection of project site revealed that no difference was found in species of tree and the girth of tree. Hence, the State Government is also requested to upload Site Inspection Report of DFO concerned.
- The State Government has proposed non-forest land, having khasra no. 211min, 213, 214 and 385 Min (total area 25 hectare), which plantation was carried out under Aravalli Project (1991-2000) in Aravalli areas of south Haryana has been considered as "forests" for the purpose of FCA 1980. Therefore, this land has been selected for restoration that are in highly degraded state and the density is less than 40%. This land identified for Compensatory Afforestation are suitable for restoration of degraded forest landscape under Bonn Challenge. Further, the State Government has submitted that the ownership of the land is not with forest Department. In this regard the State Government is requested to clarify under which extant of Van(Sanrakshan Evam Samvardhan) Rules, 2023 such land has been identified for CA and land record of such land needs to be provided.
- NPV sheet uploaded in part-II at 13(ii) alongwith CA Scheme revealed that NPV has charged wrt. very dense forest whereas density mentioned in part-II as 0.3. Hence, revised NPV sheet needs to be uploaded accordingly.
