Please refer to the subject and reference cited and I am directed to request to submit the following information/documents/clarification to this office at the earliest for consideration of the subject proposal under FCA, 1980;


- The kml file uploaded by the User Agency has been scrutinized and it is found that, a part of the forest area proposed for diversion is falling in Pakhal Wildlife Sanctuary (DSS report is annexed). Hence, concerned DFO may be directed to re-verify the status of the forest area (whether the area proposed forest area falls in protecte area/sanctuary or its eco-sensitive zone) and submit a report please;
- In the kml file, it is observed that, some structures are already exists in the forest area proposed for diversion. Hence, details of such structure and report on any work in violation of FCA, 1980 may be furnished.
- As per the kml file, there is a road already existing in RF area and some patch is overlapping in the forest area proposed for diversion. Hence, legal status of existing road and details i.e. RoW or earlier diversion details, if any may be provided;
- As per the time line report in parivesh portal, it is evident that date of processing by different authorities differs with the dates reported in hard copies. State Government may direct all processing authorities concerned to follow Ministry's guideline strictly and process the proposal



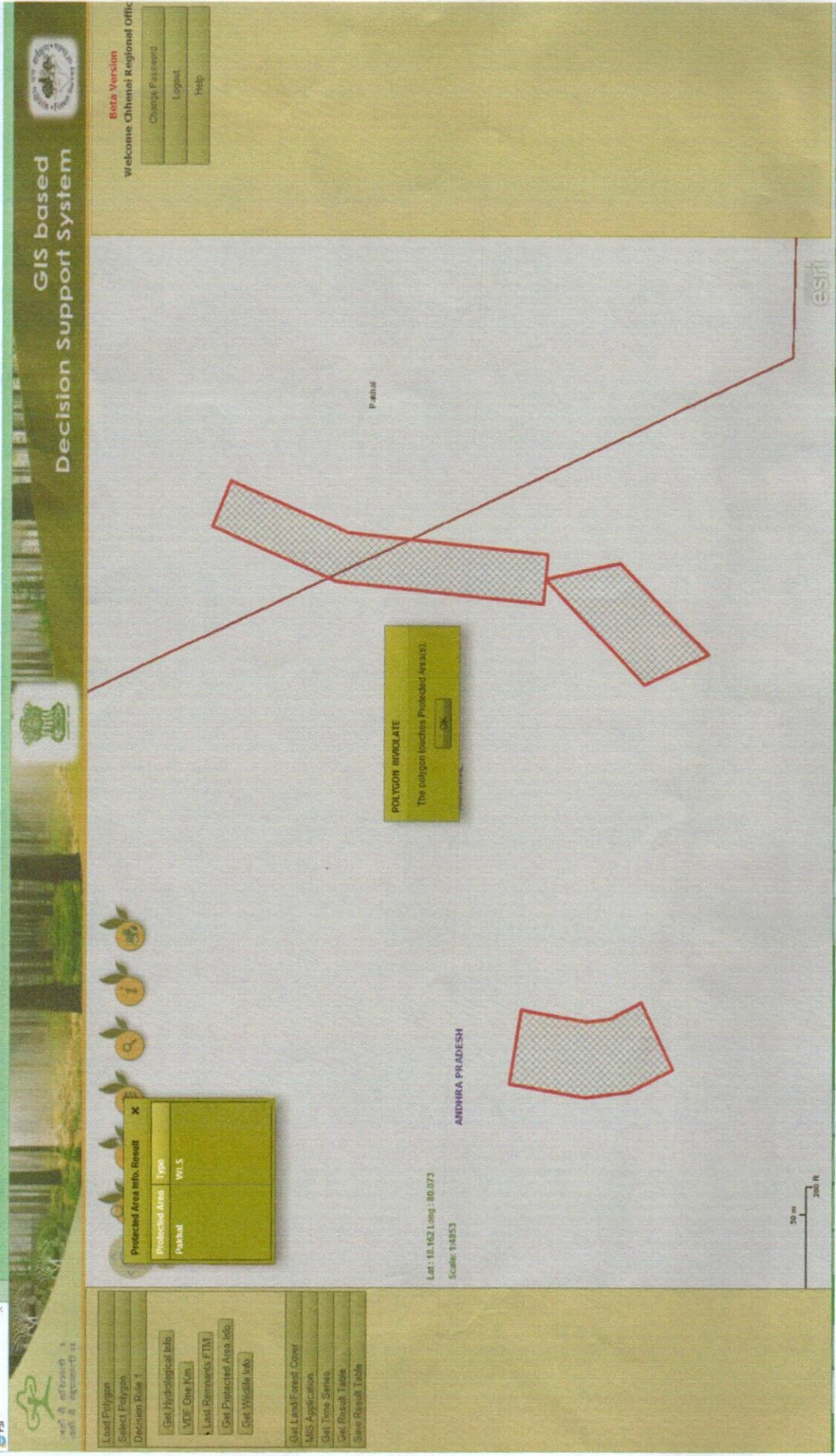
