With reference to the above subject, Executive Engineer, VJNL, UBP Division No.4, Hosadurga has submitted a proposal through web portal mode for submission of application for modification in the location and extent of forest land in already Stage-II approved Forest Clearance involves reduction of utilization of forest land from 111.57 Ha to 104.63 Ha for construction of Chitradurga Branch Canal in Chitradurga district for approval under Forest (Conservation) Act, 1980. Accordingly, a communication through online was received to process the said proposal and submit specific opinion vide ref (1).

The Range Forest officer, Hosadurga Range, Hosadurga have visited above subject proposal site. The project site was inspected with reference to the Maps and other documents. The Assistant Conservator of Forests, Hiriyyur Sub-Division, Hiriyyur has submitted report vide ref (3) and (4). The following observations were made during the site inspection.

1. The documents submitted for the proposal is 40.84 Ha which is in correct. Actually, the area should be shown as 40.85 Ha of Lakkihalli Forest area in the Hosadurga Range.

The user agency has to submit compliance report for the site inspection memo with necessary justification at the earliest.
