Diversion of 3.218 ha of forest land in favour of HPPWD for the construction of Link road from Dhar to Dhangar via Lunsu in district Kangra, RD 00/0 to 6/500, within the jurisdiction of Dehra Forest Division Distt Kangra, HP.

1. In online part-1 as well as in hard copy of the proposal, in the justification it has been mentioned that there is already kutcha road along the proposed alignment which is being fully utilized. Further, against column No.D(ii), 'No', has been mentioned and against column No.D(ii)(a), There Already exists a path which shall be followed, has been mentioned. Thus it is clear that there is no need to explore alternatives. But in the details placed at P.No.26 of the proposal folder, three alternate alignments have been examined, out of which alternate-I, has been selected. This document is not required to be placed in the proposal folder.

2. Against the detail of violation(s), the forest land involved in violation (in ha.): 3.2180 ha has been mentioned whereas in the hard copy of the proposal in joint inspection of the committee, Area violated 3.0616ha and dumping site 2 Nos. 0.1564 ha has been mentioned. This is required to be clarified by the DFO concerned whether the violation has been done only over 0.1564 ha forest area or the whole forest area including dumping sites has been violated by the user agency. Necessary corrections are required to be made in online as well as in hard copy of the proposal as per actual violation done by the UA over forest land.

3. In the site inspection report uploaded online and placed at P.No.49 of the proposal folder, out of para, (a) & (b), both the paras have been ticked marked as (√) thus it can not be made out whether the user agency has violated the provisions of FCA or not. The revised site inspection report on proper format of site inspection report is required to be uploaded and placed

in the proposal folder.

4. Compensatory has been proposed over 6.25 ha of forest land and penal CA has been proposed over 12.25 ha of forest land whereas the site suitability certificate placed at P.No.57 of the proposal folder, only for 3.2180 ha of forest land proposed for diversion has been given. Site suitability certificate is a document showing the suitability of the forest area proposed for CA or penal CA. Thus the CA site and penal CA site suitability certificates of the forest land proposed for CA and Penal CA for 6.25 ha and 12.25 ha is required to be uploaded in online part-II and submitted in duplicate to this office for placing the same in the proposal folder.

5. Although reclamation plan of the forest area proposed for dumping sites has been placed at P.No.63-64 of the proposal folder has been placed but cost estimates of engineering structures and plantation part has not been found

placed in the proposal folder.

6. Calculation of NPV has not been found placed in the proposal folder. There is violation in the present proposal hence the calculation of penal NPV is required to be made as per GoI guidelines dated 27.1.2018.
