2. The following shortcomings have still not been attended which may be attended complete in all respect :-

1. The detail mentioned / shown in Part-I, Para-E (ii) & (iii) is still not corrected which may be reviewed.
2. The component as mentioned in the layout Plan of the proposed project is still not matching with the component mentioned in component wise breakup (Part-I, B-2.4).
3. In reply to point No.7 of GoI, it has been stated that field book is not a part of project is not correct, the field book alongwith the tattima and zamabandi are the part of revenue papers and required to be uploaded.
4. In reply to point No. 11 of GoI, the legal status of DA land mentioned in Part-II, Para 2 is still mismatching with Part- II, Sr. No. 5(v) which need to be reviewed and revised.
5. The approved and proposed project has still not been marked in distinct colour in KML file.
6. In reply point No. 14 of GoI, polygon of 0.1964 ha. land in CD form with survival percentage of plantation raised as per the approved Reclamation Plan has not been submitted to this office.
7. The reply to point No. 15 of GoI is still in consonance with the observation of GoI.
8. The recommendation letter of DFO uploaded in para-II, Para-16 is still found blank.
9. The shape of the diversion area (DA) marked on the SoI map is still not in proper shape as per the revenue record. The revised SoI map of DA may be uploaded against the appropriate column of the portal.

You are, therefore, requested to kindly ensure to submit the reply to this office, only after satisfactory compliance of all the observations/ shortcomings as mentioned above.

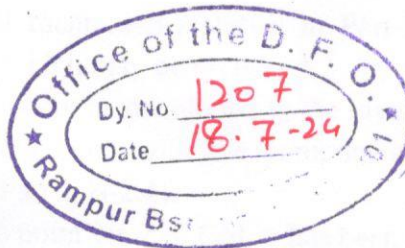
