In inviting a reference to the subject cited above, I am to inform you that the Regional Empowered Committee (REC) in its meeting held on 28.07.2022 had discussed this instant proposal. After detailed discussion by the Committee the proposal was recommended for sending to Ministry for approval by the competent authority subject to submission of the following:

- The State Govt shall prepare soil conservation and biodiversity measures in and around the 2 lakes below the drill site and submit the revised plan at the cost of Rs 25.00 Lakhs.
- No damages to the forest during widening of the road particularly the adjacent patches of plantation.
- The User Agency should provide income generation activities for livelihood of nearby villagers in consultation with the State Govt.
- Fencing as the approach road passes through thick forests & plantation by the user agency, wherever required.
- Additional information sought by IRO, Shillong vide letter dated 22.11.2021 including revised NPV calculation to be submitted at the earliest.

In view of the above, the State Govt is requested to submit information desired by REC to this office at the earliest so as to enable this office for taking further necessary action.
