
1. Khanvel - Kherdi road for proposal for diversion of Protected Forest Land area 7.70 ha.
2. Dapada, Satmalia & Khadoli stretch road under NH 848A for diversion of Protected & Reserved Forest land area 3.5367 ha.
3. Satmalia, Khadoli & Surangi stretch road under NH 848A for diversion of Protected & Reserved Forest land area 2.607 ha.

Madam.

With reference to the above subject, it is to inform your good-self that a total of 15 Hectare is proposed for diversion of Reserved / Protected Forest land in lieu of Widening / Construction work. Accordingly, Compensatory plantation works are to be taken up in equal area of forestland sought for diversion in the above said proposal. It is hereby requested to provide the revenue land in lieu of above diversion of forest land for carrying out the Compensatory Afforestation. It is also pertinent to request that the land allotted shall be encumbrance free and subsequently shall be mutated and transferred to Forest Department, Dadra & Nagar Haveli.

An early action in the matter is requested so that above proposal under reference shall be processed further.

Sir,

With reference to the above subject, kindly find herewith the revised guidelines to be compiled in respect of wildlife clearances while diverting Protected Areas for development propose as detailed below:-

1. Mandatory submission of animal passage plans:

A guidance document, namely, 'Eco - friendly Measures to Mitigate Impacts of Linear Infrastructure on Wild Life' has been prepared by the Ministry. The document prescribes measures, both structural and non - structural, to be adopted while designing linear infrastructure projects through wildlife habitats. Whenever a linear infrastructure project is planned through a wildlife habitat, an animal passage plan shall be prepared by the user agency in consultation with the Chief Wild Life Warden for submission along with the project proposal.

2. Cost of mitigation measures:

Measures to mitigate impacts of projects in protected areas and eco - sensitive zones should be part of project proposals. Instead of imposing a fixed cost, mitigation measures and costs associated with such measures should be prescribed while recommending project proposals.

In view of above guidelines kindly take necessary actions on the matter in respect of the proposal for wildlife clearance as mentioned above
