- 1) 7/12 extract of Gut No14 and 15 Marathi copies not submitted in the proposal
- 2) 7/12 extract of Gut No.363 & 358 English and Marathi copies not submitted in the proposal.
- 3) Consolidated diverted area KML file not submitted. Diverted KML file should to be submitted a single polygon showing all gut number and survey number wise along with starting and ending points.
- 4) Non forest land should be highlighted single polygon on diverted area KML file
- 5) Compartment boundary is not shown on C.A KML file.
- 6) Forest Compartment boundary should to be shown in diverted area KML file.
- 7) User Agency has not mentioned date on his all undertakings. The same need to be complied

The above discrepancies should be complied to this office at the earliest.
