Reply of this office EDS dated 13.07.2015 uploaded online by State Govt. on 01.08.2018 was examined. In this regard, I am directed to inform that the State Govt. may attend the shortcomings as mentioned below:-

1. Short narrative of the proposal does not provide adequate information about the project.
Action Required:- State Govt. may upload correct information of short narrative of the project at para-A-1 (iii) online Part I.
2. Justification for locating the project in forest land is not C/S by DFO.
Action Required:- State Govt. may upload brief note on justification for locating the project on forest land C/S by DFO.
3. Alternative examined of the road proposed for diversion has still not been submitted.
Action required:- State Govt. may upload the map indicating the alternative examined of the road proposed for diversion at para -D (ii) (a) of online Part I.
4. In CA area map column, google earth image is uploaded with only two co-ordinates whereas hard copy is submitted that too of different size/shape and also not authenticated by DFO.
Action required:- State Govt. may submit the original hard copy of geo referenced digital map of CA duly C/S by DFO and may upload the same at para - C (iv) online Part-I.
5. Working plan prescription details are not found correct.
Action Required:- State Govt. may correct the information of Working Plan prescription online.

6. Approximate distance of the proposed site of diversion from boundary of forest is shown 0.5 km in online Part II whereas is shown 4 km from RF in the reply letter vide dated 01.08.2018 from State Govt. which does not appear to be correct.

Action Required:- State Govt. may fill correct distance of the proposed site from the boundary of RF.

7. The information at para E online Part I regarding employment generation appears to be incorrect.

Action Required:- The State Govt. will review and upload the correct information at para E (ii) Part I regarding employment generation.

8. The authorization letter is not uploaded in online Part I para A3 (xvi).

Action to be taken: The State Govt. may authorization letter at para para A-3 (XVI) Part I.

9. In Part I para B 2.4, village names are filled instead of components of the project in component wise breakup column.

Action Required:- State Govt. may fill correct details in component wise breakup at para B 2.4 online Part I.

10. Original hard copy of the complete proposal is not submitted to this office.

Action Required: The State govt. may submit original hard copy of complete proposal.

11. Land schedule found incorrect.

Action Required: State Govt. may submit correct hard copy of the land schedule, in original.
