Sir,

During scrutiny of your above diversion proposal vis-à-vis documents, the following discrepancies have been noticed which need to be rectified and resubmitted for processing of the diversion proposal.

**Undertakings/ Certificates to be furnished**

1. Approval/ permission/ consent of the competent authority regarding the proposed project in scheduled area.
2. Certificate as regards displacement and rehabilitation of project affected persons.
3. Certificate under FRA- 2006 in respect of forest land proposed for diversion.
4. Certificate as regards Status of land (Forest and Non-forest) as on 25.10.1980.  
(N.B.- The status certificate should be corrected and complete in respect of all plots involved in the project).
5. Pending Court Matters, if any.
6. Visible copy of project approval letter.

**Authenticated Maps and documents to be furnished**

1. SOI Topo Sheet (1:50000) showing forest land required for diversion and boundary of adjoining forest land.
2. Cadastral lay out plan of the proposed forest land for Kanpur Canal Project should be signed by concerned Range Officers, Tahasildars and User Agency.
3. Proposed land use plan in respect of applied forest land.
4. DGPS map showing patch wise DGPS coordinates of the forest land under different category involved in the project proposed for diversion and DGPS coordinates of all patches of forest land involved in the project.
5. Cost benefit analysis of the project in the prescribed format as per revised guideline dated 01.08.2017.
6. Category/ patch/ village wise break up of forest land proposed for diversion.
7. Details of approvals obtained/ sought for under the Act in respect of the project.
8. During verification of identified non-forest land for CA through DSS it is found that 169.00 ha land coming under MDF category. Hence you are requested to contact the Range Officer, BJP to find out the exact nos of seedling to be planted in the identified CA land in village Lungajhar. Accordingly you should select the degraded forest land to accommodate the balance number of seedlings for CA.

9. Check list in the prescribed format along with specific information specific to irrigation.
10. Proposed forest land use plan in compliance with para- 4.5 of FC Act guideline published during 2018.
11. Submission of documents in original or photo copy of the same. in case original documents is lost, duly authenticated from the record by the issuing authority with signature and official seal.
12. Map showing the distance from Kanpur Canal Basudevpur, Keonjhar to National Park/ Sanctuary, Tiger Reserved and Elephant Corridor duly authenticated by the concerned Range Officer.
