Sub: Proposal for diversion of 27.19 ha of forest land for construction of Tamen to Dollungmukh Road (Phase I) 42.03 km to 72.03 km in Lower Subansiri and Papum Pare districts of Arunachal Pradesh by PWD, Govt of Arunachal Pradesh.

Sir,

Please refer to State Govt online proposal No. FP/AS/ROAD/448415/2023 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 (1) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, I am directed to inform that the proposal referred above has been examined in this office in the light of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and rules/guidelines framed thereunder and observed the following lacking information/documents:

- 1) The consent of NBWL in respect of the proposed area i.e. 24.131 ha (30.178 Km road length) falling under Tale WLS.
- 2) The minutes of the meeting of Project Steering Committee (PSC) of the proposal is to be submitted as per the Ministry letter FC-11/118/2021-Fc dated 25.01.2024.
- 3) Whether the proposed road is only for construction in Greenfield area, if not, FC status of the existing road and existing RoW, if FC status not obtained of the existing road, the reason thereof.
- 4) In case of involvement of widening of existing road, clarification may be submitted whether the instant proposal seeks FC for both the existing road and additional area required for construction for 4 lane and provide along with the details of the road in the format as under:


- 5) The 3 alternate route examination of the proposed road incase of new road construction along with the SOI map indicating with distinct color.
- 6) The Cost Benefit analysis to be resubmitted for the proposed area i.e 27.19 ha in the new prescribed format.



- 7) The detail break up area of the muck dumping location and proposed road involved in the proposal.
- 8) The Muck Dumping Plan approved by the concerned DFO mentioning the nos, of dumping locations, GPS coordinates and quantity of the muck to be extracted and dumped from the proposed area,
- 9) Whether any non forest land is identified for the muck dumping location in this proposal as 9 nos of such location has been submitted.
- 10) To clarify on 'NIL' report on the tree enumeration list in respect to the proposed area i.e. 3.05 ha as trees canopy has been observed as per the DSS.
- 11) The current status of mutation and notification of identified CA area i.e. Venyi Happa VFR.
- 12) The comment of the State Govt as the proposed area is 'INVIOLATE' due to the presence of hydrological layer i.e. river as per the DSS.
- 13) The calculation of the NPV of the proposed area.
- 14) The alternate CA site for 13.926 Ha along with SOI map, site suitability certificate, GPS co-ordinates, kml file, etc. as out of the total 54.40 ha CA site identified 0.995 ha is Very Dense Forest, 12.931 ha is Moderate Dense Forest, 21.882 ha is open forest and 18.898 ha is non forest as per the DSS.

State Govt is requested to furnish the above information to this office for further processing of this instant proposal.


