

With reference to the above, it is to inform you that on scrutiny of the forest diversion proposal submitted by you for use of forest land for 6 Nos. drilling location (DPDD, DPDH, DPDI, DPDJ, DPK and DPDL) at Doyang Reserve Forest under Golaghat Division by ONGC, following deficiencies are noticed resulting our inability to further processing of the proposal.

1. The Form – A Part – III not submitted by you.
2. The Net Present Value (NPV) wrongly calculated submitted by the DFO, Golaghat Division.
3. The wages rate as per the Compensatory Afforestation Scheme submitted by the DFO, Golaghat Division is Rs. 240/- DL instead of Rs. 273/- DL as per new wages rate.
4. The DFO, Golaghat Division has submitted the proposed Compensatory Afforestation area 5.46 hectares in Lower-Doigrung Wildlife Sanctuary. The proposed Compensatory Afforestation area is a part of Wildlife Sanctuary, recommendation/ approval of Chief Wildlife Warden is required.

Therefore, the forest diversion proposal is returned herewith in original (4 sets). You are requested to re-submit the rectified / corrected diversion proposal along with all the above observation / documents.


