With reference to the above subject, the office of the undersigned has submitted information along with documents as EDS query raised by the Government of India vide letter Dt. 27.07.2023 under Ref(5). Further, the Chief Conservator of Forests, Ballari Circle, Ballari has raised EDS query vide letter Dt.27.07.2023.

Further, it is requested to submit the following information / documents for processing of the proposal.

- 1) As reported by the Range Forest officer, Sandur North Range, Sandur and Assistant Conservator of Forests, Ballari Sub-Division, Ballari, 0.73 ha of approach road is part of Ramanamalai forest Block which is declared as Section-04 vide Dt.28.02.1985, during the process of settlement joint survey (with Revenue department) was carried out. After joint survey, it is found that the actual area is 0.95 ha (revised from 0.73 ha) and it falls in Ramanamalai Forest block. Therefore, it is requested to include this stretch also in the proposal.

- 2) The earlier lessee M/s Kanhaiyalal Dudheria had identified C&D land in Sy No.156 of Rayapura village Ballari Taluk, Ballari District over an extent of 10.12 ha and in Sy No. 3 of Garaga Village Hospete Taluk, Vijayanagara District over an extent of 7.10 ha. However, this land is not transferred and mutated in favour of Forest Department. However, you have identified CA land only for 15.30 ha instead of 32.49 ha of proposed area. Therefore, it is requested to identify CA land for remaining area of 17.19 ha (32.49 ha – 15.30 ha).

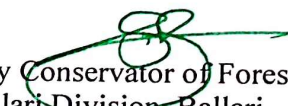
