It is to inform you that against your online application for diversion of forestland for Kotre Basantpur Pachmo OCP 1372.98 ha. queries was raised vide this office letter no. 2176 dated 10.07.2019. The compliance has been submitted by you vide your letter no. GM/KBP/2019/237 dated 20.07.2019, which is unsatisfactory and unacceptable. Detail of which is given as under-

It is requested to please procure it from DC/CO Office and submit in this office.
6.	Tree enumeration list संलग्न नहीं है।	Application for tree enumeration has been given to DFO, Bokaro vide letter no. GM(KBP)/2019/196, Date 06.06.2019, Undertaking for the same is enclosed.	Tree enumeration has to be done before application and an enumeration list has to be attached with it at the time of proposal. Your reply is highly superficial as it has to be done by yourself under the supervision of forest staffs, for which the RFO, Tenughat has been directed. Please do it as early as possible.
