
In continuation to this office letter under reference (i) above, I am to inform that the submitted KML/shape file of the proposed compensatory afforestation area as submitted by the State Govt. letter under reference (iii) above is found to be incorrect i.e., 366.03 ha instead of 260.17 ha as mentioned in the hard copy. As per the DSS report of FSI Dehradun (report enclosed), 2.09 ha is under very dense forest, 146.40 ha is under moderately dense forest and 217.54 ha is under open forest. Further, the soft copy of the KML/shape file of the proposed area is not found in the enclosed CD.



In view of the above, State Govt. is requested to kindly verify the area proposed for CA and submit the following information to this office at the earliest for further processing of the proposal:-

- (1) The corrected shape/KML file of the proposed CA area after conducting the site visit by an officer not below the rank of Conservator of Forest mentioning vegetation data and forest cover density, or else, an alternate CA site may be submitted along with SOI maps, site suitability certificate, GPS-coordinates, shape file etc.
- (2) The soft copy of the KML/Shape file of the proposed area.
