Subject: Proposed forest diversion of protected forest in Kanpur Dehat District from km 0.000 to km 21.000 for 20.631 ha with felling of 2,026 no of trees, Kanpur Nagar District from km 22.000 to km 54.000 for 29.586 ha with felling of 2,889 no of trees and in Fatehpur District from km 55.000 to km 82.200 for 25.3065 ha with felling of 6,743 no of trees; in total diversion of 75.5235 ha of protected forest and felling of 11,658 number of trees-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. Information at A-3 (xvii) regarding person making application on behalf of user agency is incomplete as the signature of authorised person has not been authenticated.
2. Details provided at B-2.3 in part I for village wise breakup of forest and non forest land is incorrect.
3. Geo coordinates of all key points of proposed forest land for diversion has not been provided and the same needs submission.
4. Kml file uploaded for proposed forest land diversion has been provided same colour code for three forest division which cannot be deciphered clearly.
5. The cost benefit analysis provided at G (i) (a) in part I is incorrect and calculations have been carried out on wrong values.
6. The certificate under FRA 2006 from DM Kanpur Dehat is without seal and from DM Fatehpur signature is without date and name.
7. Calculation of proposed forest land area shown in land schedule is not based on position of ROW shown in letters of PWD officials.
8. No Objection Certificate from land owning authority has also not been submitted with the proposal.
9. Proposal is without submission of profile and background providing different aspects of it.
10. Various documents of the proposal are without name, date & seal of the signing authorities.
11. The estimation of crown density for Social Forestry Division Fatehpur is on lower side and requires revision.

12. (a) Kml file of proposed compensatory afforestation site (Derapur RF, extent 11.777 ha, Rasulabad Range, Forest Division Kanpur Dehat) shows existence of permanent structure and shows lateral shift also.
- (b) Proposed compensatory afforestation site (Pachura Forest Block, extent 10.050 ha, Amauli Range, Social Forestry Division, Fatehpur) shows existence of patches of vegetation within proposed area and kml file of fourth patch in Rithawa Forest Block is not opening. Detailed estimate of CA has not been uploaded.
- (c) Legal status of proposed CA site for patch no.1,3 &4 of Social Forestry Division, Kanpur Nagar has not been provided with the proposal.
13. Rates adopted for Compensatory Afforestation schemes of three divisions are different (huge variance) and reasons for the same has not been provided with the proposal.
14. As the proposal is having extent of diversion > 40 ha, site inspection report of Nodal Conservator of Forests is mandatory. The site inspection report has not been provided with the proposal.
15. Part V of the proposal to be filled by the State Government has not been uploaded.
16. Various mandatory undertakings and documents like site suitability certificate, undertaking regarding wildlife area, undertaking regarding van Swaroop bhumi etc for Social Forestry Division, Fatehpur and Forest Division, Kanpur Dehat have not been uploaded.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
