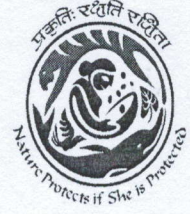

1. The current status of the environment clearance of this instant proposal as the length of the proposed road is 225 Km which involved additional right of way as per the Ministry letter 8.0.2559(E) dated 22.08.2013.
2. The actual date of completion of work of existing road with 12 m ROW to be provided in order to avoid court case and other complicity in future.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
