Sub: Proposal for diversion of forest land for construction of Water Supply Scheme Gangbugh in Kamraj Forest Division.

Ref: Proposal No. FP/JK/Water/143677/2021.

This is in reference to the above proposal. The Conservator of Forests, North Circle Sopore/DFO Kamraj/User Agency are requested to upload the following documents, within two days:-

1. The Net Present Value of the forest land proposed to be diverted amounting to Rs. 55,920/- has been assessed and uploaded on the portal. As per MoEF &CC guidelines, NPV is exempted for projects involving forest land upto 1 Ha in case of (i) overhead Tanks, (ii) Village tanks and laying of underground drinking water pipeline upto 4" diameter, provided that (a) no felling of trees is involved, (b) alternate forest land is not available, (c) the project is of noncommercial nature and is part of the Plan/Non-Plan scheme of Government, and (d) area is outside any National Park or Wildlife Sanctuary.

In this proposal, forest land for construction of Service Reservoir and laying of pipelines proposed to be diverted is less than 1 Ha and no felling of trees is involved. The report regarding diameter of the proposed pipe line need to be furnished/uploaded and accordingly applicability of the NPV in this case be decided.

2. Permanent/regular employment to 20 persons have been given under column E (i) in Part-1 of Form-A by the user agency. Justification in this regard need to be given by the user agency.

3. Since in this proposal construction of Service Reservoir and laying of pipelines has been proposed, the shape of the forest land proposed to be diverted under column A 1 (vi) need to be changed from non linear to Hybrid by the user agency.

4. One page of the CA plan has been uploaded at the relevant place and other page at additional documents in part-II by the DFO. The complete CA plan

need to be uploaded by the DFO.
