Kindly refer to Your Office letter No .Kashang HEP Stage-I&III/5382 dated 18.09.2020 on the subject cited above.

This is in compliance to the observations/shortcomings noticed on the subject cited proposal submitted, the point wise rectification/submission is as under:-

1. The papers/ Checklist placed in the proposal folders has been marked and placed properly.
2. The stamp of the Nodal officer FC affixed in the MoEF&CC checklist has already been deleted.
3. The Survey sheet and digital maps for project has been prepared by depicting the component to be constructed in the proposed diverted land. Colored copy of survey sheet & digital map both are placed in the proposal folder; Checklist No 7 is being attached dully signed by the DFO.
4. The checklist No 7 placed in the proposal folder is being revised with desired rectifications.
5. Check list No 4 & 10 are being revised by giving complete details of area, trees involved and alternative examined and reason for their rejection.
6. The colored scan copy of the Layout plan dully authenticated by the authorized signatory is being attached.
7. Checklist No II has already been signed by the DFO, where as your good office has unnecessarily raised this observation.
8. Checklist No 15 is being revised & attached dully signed by DFO.
9. The User agency has prepared the proposal as per the latest revise checklist issued by MoEF&CC in the year 2019.
10. The certificate regarding the distance of Lippa Asarang wildlife Sanctuary. NBWL has already accorded the Clearances, in which the distance from the project has already mentioned in it although Certificate of DF wildlife clarifying the distance is also being attached.
11. The authorization letter dully authorized by the competent authority has already placed in the proposal folder at page No 158.


Beside above reply to the short coming / discrepancies observed in the revenue papers are as under:-


