महोदय,


उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. On perusal of the proposal, it has been noticed that college can be connected from nearest point of existing road instead of taking 0.58 ha reserve forest land which includes felling of 85 trees. State Government may submit clarification in this regard.
2. State Government is requested to direct the concerned DFO to personally visit the site and explore the alternatives in view of point No. 01 mentioned above.
3. Out of 0.58 ha reserve forest land 0.16 ha area is selected for muck disposal which appears proportionally more. State Government is requested to submit justification for the requirement of this much land proposed for muck dumping and explore the possibility of selecting non-forest area for muck-dumping.
4. Administrative approval is submitted to connect the college but the proposed alignment is going beyond the college. State Government may submit clarification in this regard.

5. Detail of alternative explored is neither submitted nor uploaded. State Government may submit/upload the same.
6. Date is not mentioned in the proceedings of the Sub-Divisional level Committee (SDLC) meeting under FRA. State Government may submit/ upload the SDLC meeting proceedings with date prior to the Stage-II approval.
7. Detail of trees falling under girth-class of 0-30 cm is not submitted/ uploaded. State Government may provide/ upload the details of trees in girth-class of 0-30 cm.
8. Plantation scheme of Rs. 22,08,661/- is uploaded for planting 850 trees. State Government may submit justification as per current rate in this regard.
9. Aerial distance certificate is not countersigned by the DFO. State Government may submit the aerial distance certificate duly countersigned by the concerned DFO.
10. Density is mentioned as 0.2 for 85 trees in 0.806 ha area appears incorrect. State Government may review the same and submit the correct information/ document.
11. State Government may submit the muck disposal plan duly authenticated by the concerned DFO after thorough check because 0.16 ha in RF only for muck disposal seems more than required.
12. Administrative approval and Geologist report uploaded online is incomplete. State Government may submit/ upload the complete administrative approval and geologist report.
