महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्निलिखित कमियां पाई गयी है:

- 1. The proposal is not listed in cases of 2183 submitted to Hon'ble High Court. However, the committee report stated that the violation have been done by local Panchayat. Therefore the comments over action taken under Local acts by the states and proof in this regard may be submitted by the state govt.
- 2. The calculation of Penal NPV should includes 12% interest from the date of violation reported till the deposit is made.
- 3. State Govt. may submit the comments over guideline para 1.21 (ii) (c) of the handbook of FCA.
- 4. The scientific name of tree are not given in online portal at Para 4 (ii). However given in hard copy but scientific names of trees ' Konhal'& 'Siris' are not given even in hard copy.
- 5. The villages to be benefited by the proposed road need to be marked over KML file alongwith the alternative examined.
- 6. In the KML file the proposed alignment is linking two existing roads which is not necessarily required. Therefore, the state govt. may revise the proposal upto point-14 of the geo-referenced map.
- 7. The proposed area i.e. 0.6472 ha for muck dumping in forest area. Therefore following details may be submitted by the state govt.
 - a) Tree Enumeration details in separate over muck dumping sites.
 - b) Comments of DFO for examining the possibility to avoid forest land for muck dumping.
- 8. In muck dumping plan the muck proposed to be dumped is quantified after swell factor is 29197 cum while the capacity of dumping sites are quantified on higher side. Therefore, unnecessary land has been taken for dumping which can be reduced. The comments in this regard may be submitted by the state govt. Further, the calculation carried out in Annexure B-I is not correct in hard copy regarding muck dumping plan.

- 9. In the DSS analysis, it is found that the CA area is having 1 ha VDF and 3 ha MDF. Therefore the State Govt. may replace the area with some other suitable area having density less than 0.4 for CA.
- 10. Khasra details of CA area with certificate regarding no plantation has been done in the past over the proposed land.
